Mr. Estrada announced there were no advanced requests to address the Committee.

PRESENTATIONS & REPORTS

Mr. Heinlein indicated we sold Series C, the remaining Measure EE Bonds. We had a lot of interest in our bond sale, over 320 million for the 102 million we were selling. Mr. Heinlein reviewed the Final Financing Summary prepared by Keygent Advisors. He explained the all-inclusive interest rate of 2.23% and net repayment ratio of 1.34 to 1. Mrs. Umeck congratulated and thanked everyone for a job well done.

Measure EE Update from District Staff

Mr. Heinlein presented the COC Financial Report:

From this point on we will be separating the previous COC Report. We will be presenting a financial report and a project update presentation. This COC Financial Report is from the new software, and has been revised to tie into the Bond Language from the Measure EE Ballot.

- Page 2 is a Budget View for the entire program.
- Page 3-40 is the Budget View by campus, followed by the Project Summary. He
 noted on the Project Summary, one will see completed or an estimated
 completion date after the project name.
- The remaining report is the detailed expenditure backup.

Mr. Aholt questioned how a project can be complete with a remaining encumbered balance? Mr. Heinlein stated the construction is completed; however, retention needs to be paid.

Mr. Heinlein added this new report ties in the Master Plan to the Bond Language. The Budget View is from the Bond language, the Project Summary is from the Master Plan.

Mr. Heinlein explained the "Other Allowable Project" are other projects listed in the Bond Language that is not listed under a school site.

Mr. Heinlein presented a photo presentation of all the projects since the last COC meeting. He also reviewed the list of contracts that went to the Board since the May 5, 2020 Board meeting as well as the Notice of Completions.

Mr. Gibbs inquired how the District awards contracts? Ms. Rubenstein reviewed Prequalification of Contractors, Request for Proposals, CUPCCAA (California Uniform Public Construction Cost Accounting Act) limits, Informal and Formal Bid procedures. Mr. Heinlein added on our website one will see our bids and current prequalified contractors.

Mr. Heinlein presented the Facilities Staff Cost Allocations Report. This report will use actual expenditures for the calculations rather than budgets as to provide more accurate accountability.

Mr. Heinlein shared an upcoming project to install Topcat speaker system in each classroom to provide a full-range audio for dynamic, media-rich classrooms. This will help everyone hear better while wearing masks. Dr. Hawkins added the teachers asked for this and are very excited. Mr. Gibbs questioned if this project was being paid by Measure EE? Mr. Heinlein said yes as there are remaining funds in the Communication/PA Project budget.

Mr. Lin inquired if sneeze guards or PPE will be provided from Measure EE? Mr. Heinlein indicated no, and stated the District has received 6 million from the State for Pandemic items.

Mr. Gibbs asked about the talks regarding the State budget deficits to provide funding to schools? Mr. Heinlein said it is challenging to the District as there are delays in when we received the funding. He noted the District cannot not borrow from Measure EE or CFD's.

Dr. Hawkins thanked the Facilities Department for all of their hard work during this time. Since the closure on March 13, 2020, this department has continued to move forward with new contracts, taking over the Board agenda.
