Focusing on both academic and social areas for success, our focus incorporates such powerful components as peer tutoring, buddy classes, student run games, student service, sixth grade leadership, peer mentoring, library assistants, and a "Circle of Friends" inclusion program throughout a student's day. #### 2023-24 School Safety Plan

Mountainview Elementary School provides a safe, clean environment for learning through proper facilities maintenance and campus supervision. Our Comprehensive School Safety Plan is updated annually. The plan includes sections on child abuse reporting, disaster preparedness, suspension and expulsion, dangerous student notification, sexual harassment, dress codes, and hate crime reporting. Fire drills are conducted monthly and earthquake and lockdown drills are held four times each year. The plan was discussed at our school site council and staff meetings in December/January and submitted to the Board of Trustees for approval in March.

Mountainview Elementary School is a closed campus. During school hours, the entrance is secured to ensure visitors check in with the front office. All visitors are required to sign in to our volunteer management system, wear a visitor's badge during their stay, and check out at the front office upon departure.

#### **Professional Development**

Since 1988, California has sought to provide intensive learning experiences for beginning teachers. To provide an effective transition into the teaching career for first-year and second-year teachers, several programs have been developed statewide and are in use in our district. The Beginning Teacher Induction Program extends individual training and support in the practice of teaching. Additionally, we have a Peer Assistance and Review (PAR) program to extend assistance and support to credentialed teachers newly hired who may need support transitioning into our school district.

Professional growth activities are planned annually based on current needs and input received from staff. This year the teachers' work calendar includes ongoing professional development that focus on best practices now that we are back to inperson learning. Most Professional Development opportunities involve an element of choice from a menu of options pertinent to programs being used this year, including but not limited to continued integration of iReady ELA and Math, NextGen math, Stemscopes for Science, and Studies Weekly for Social Studies. Teachers have ongoing opportunities for support from our Teachers on Special Assignment (TOSA) workshops, and planning time within grade level teams to implement the State Standards. Staff development during Tuesday staff meetings primarily focuses on continued implementation of effective instructional strategies, and continued lesson development to help students master state standards in English Language Arts (ELA) and mathematics. We continue to implement 30 minutes of designated ELD instruction daily as well as integrated support for ELD students during other content instruction, Intervention for struggling students in core content areas, and targeted listening and speaking activities to meet standards. Collaborative Planning time continues to be made available on designated Wednesdays allowing teachers the time to plan together within and across grade levels focused on increasing student achievement.
